

EFTTEX 2023 EXHIBITION TERMS AND CONDITIONS

at HUNGEXPO Budapest Congress and Exhibition Centre Zrt Hungary, 1101 Budapest, Albertirsai Road 10, 15-17 June 2023.

General rules

1. Definitions

- i) 'The Exhibition' means EFTTEX 2023 to be held 15th, 16th and 17th June 2023 at HUNGEXPO Budapest Congress and Exhibition Centre Zrt. Hungary, 1101 Budapest, Albertirsai Road 10.
- ii) 'The Organiser' shall mean EFTTEX Trading Ltd.
- iii) 'The Exhibitor' means any company, firm or legal entity who has ordered display space at the Exhibition.

2. Shell Scheme / Space Only

- i) Shell Scheme price includes: walls, carpet, nameboard and 1 spotlight per 4 sqm, exhibitor badges.
- ii) Space Only price includes: marked out floor area, exhibitor badges. All Exhibitors who book SPACE ONLY sites must supply a drawing of their stand design, including electricity connection points, to the Organiser at least 8 weeks before the first day of the exhibition.

3. Payment Terms

Stands booked from 1st January 2023 onwards - 100% balance due 15 days net payable to EFTTEX Ltd.

4. Opening Hours

- i) The Exhibition will be open to visitors at advertised stated times each day.
- ii) The Exhibitor undertakes to have exhibits on display, in good order, adequately attended during these periods.

5. Display Space

- i) The Organiser reserves the right to relocate the Exhibitor to a stand other than that specified in the EFTTEX Account and the digital floorplan at www.efttex.hu
- ii) Exhibitors may only sub-let part of their stand to companies for whom they act as selling agent or distributor. Exhibitors are not permitted to sub-let their entire stand to another company.
- iii) Exhibits must be completely installed by 18.00hrs on June 14th, 2023 and removed by 16.00 on June 19th 2023.
- iv) The Organiser reserves the right to re-locate stands if necessary.
- v) The Exhibitor agrees not to display or advertise goods or services other than those manufactured or carried by the Exhibitor in the normal course of business.
- vi) Exhibitors may only display fishing tackle or products directly related to fishing such as clothing, tents, seats etc or fishing tackle publications. Display of any other items will be at the discretion of the Organiser.
- vii) No explosive or inflammable materials are allowed in the exhibition premises and Exhibitors agree to comply with all instructions given by any relevant authorities to avoid the risk of fire or any other risk.

6. Height Limitations

- i) The height limit on display spaces is 2.5 metres. Any stand over this height requires written approval from the Organiser.
- ii) The height limit on displays or other items is 2.5 metres. Any display over this height requires written approval from the Organiser.

7. Intellectual Property

The Exhibitor must ensure all products/exhibits on the stand do not violate any intellectual property rights, patents, registered models or trademarks. If the Exhibitor is found to be doing so, after verification, the Organiser has the right to close down the stand with immediate effect, expel the Exhibitor from the show and no refunds will be made.

8. Removal of Exhibits

- i) No exhibits shall be packed, removed or dismantled prior to the closing of the Exhibition without written consent of the Organiser.
- ii) The Exhibitor will be liable for all storage, removal and handling charges incurred by the Organiser resulting from failure to remove all exhibits and display materials from the halls before 16.00 hrs the day after the Exhibition.
- iii) The Exhibitor must surrender any occupied shell scheme and stand items in the original condition.

9. Cancellation by Exhibitor

- i) A cancellation fee of 50% of the total sum due will be charged for all cancellations made prior to January 31st, 2023. After that date, no cancellations are acceptable, and no refunds will be made.
- ii) If the Exhibitor does not occupy the space by 19:00 Wednesday 15th June 2023, the Organiser is authorised to occupy the space as it deems to be in the best interests of the exhibition, without in any way releasing the Exhibitor from any responsibility.

10. Exhibition Cancellation, Change of Location, Curtailment or Change of Date of Exhibition

- i) In the event that by reason of any event outside the Organiser's reasonable control (including without limitation any strike or other industrial action involving the Organiser's own work force) the exhibition or any part thereof is prevented from being held in a particular location or on a particular date, the Organiser shall be entitled in its absolute discretion to cancel, relocate or change the date of all or any part of the exhibition or reduce the planned period for preparation, display or dismantling of the exhibition and in such event any refund of payments to the Exhibitor shall be at the absolute discretion of the Organiser.
- ii) Such refund, if given, shall be such proportionate share of the balance of the aggregate exhibit fees received by the Organiser in relation to the exhibition as the Organiser thinks fit after deducting expenses incurred by and reasonable compensation for the Organiser, but in no case shall the amount of any refund to the Exhibitor exceed the amount paid by the Exhibitor nor shall the Exhibitor be entitled to review or audit any of the Organiser's financial records.
- iii) The Exhibitor hereby acknowledges that in the event of the circumstances referred to in 10.i – 10.ii he shall have no right to any refund, damages or expenses.
- iv) In the event that the exhibition is cancelled by the Organiser for commercial reasons, including without limitation lack of support, then all payments made by the Exhibitor to the Organiser will be refunded, but the Exhibitor hereby agrees that in such circumstances he will have no further claim (whether for damages or otherwise) against the Organiser.

11. Limitation of Liability

- i) The Exhibitor acknowledges that the Organiser shall not be held responsible for the failure of any number of attendees to attend the exhibition for any reason beyond the reasonable control of the Organiser.
- ii) Any application for stand space or any acceptance thereof by the Organiser shall not be conditional on the presence or location of any other Exhibitor at the exhibition or any other exhibition.
- iii) The Exhibitor hereby acknowledges that in the event of the circumstances referred to in 11.i – 11.ii he shall have no right to any refund, damages or expenses.

12. Exhibitor Qualification

- i) All European companies who are in the fishing industry can exhibit at EFTTEX without any limitation
- ii) All non-European companies who wish to exhibit will only be accepted if they are a Discretionary Member of EFTTA or a National Member of ASA, AFFTA, JAFTMA, CSIA or AFTA or paid the 1.500 EUR contribution fee.
- iii) Acceptance of all members and exhibitors is at the discretion of the Organiser and the relevant membership subscription must be paid where appropriate.
- iv) The Exhibitor agrees to abide by the general rules and regulations of the Organiser and hall authorities. These are listed in the Exhibitor Manual.
- v) The Organiser reserves the right to reject any application and to cancel bookings at any time for failure to conform to rules and regulations.

13. Indemnity

- i) Whilst every care will be taken by the Organiser all exhibits are shipped, delivered and handled at the Exhibitor's risk and expense.
- ii) The Exhibitor agrees to indemnify the Organiser against all costs, expenses, charges, losses or claims in consequence of damage to property or injury to members of the public or any other person and any consequential loss caused by or as a result of the act, default or negligence of the Exhibitor or his employees or any other person or persons under his direction.

14. Insurance

- i) To protect the interest of the Exhibitor it is recommended that Exhibitors have minimum insurance of 1,000,000 Euro.

15. Law Applicable

This Terms and Conditions shall be subject to English Law and the parties hereto submit to the non-exclusive jurisdiction of the Hungarian Court.
